

A Day at Camp SPECTACULAR

The program consists of two groups of 9-12 year olds and two groups of 13-16 year olds. Each group is supervised by special education teachers and camp counselors. As a team, the staff work together to give the campers a week full of fun, laughter and new friends.

Every morning begins group activities focusing on collaborative skills and group projects. Daily activities include arts & crafts, recreational swimming, music & drama, non-competitive sports & outdoor recreation, problem-solving challenges, teambuilding, guest entertainment and group discussions.

Each day ends with a special campfire ceremony during which we review the day's activities, anticipate the fun for the next day and celebrate each individual.

The last day of every session is Family Day. This is an opportunity for families to come together and share the fun at Camp Spectacular.

Admissions

- ♣ Camp is available on a first come first served basis. Acceptance into camp is contingent upon review of a complete application by the camp director, social worker and medical advisors.
- ♣ Applications will be reviewed based on the child's appropriateness for camp and his or her need for a summer program.
- ♣ Enrollment is limited to 56 campers per session. All sessions are co-ed.
- ♣ New campers are required to attend a pre-camp screening. The goal is to answer any questions from parents or campers. It also gives us a chance to



Frequently Asked Questions

Who can attend?

- ♣ Children, ages 7-16 years, with autism spectrum disorder diagnosis including Asperger's Syndrome, high functioning autism, and PDD-NOS
- ♣ Children that have average or above average language skills
- ♣ Children that have demonstrated self-management skills in community and school settings

Who cannot attend?

- ♣ Children that exhibit aggressive or self-abusive behavior
- ♣ Children that are a flight risk
- ♣ Children that require a constant one-to-one aide

Who works at camp?

- ♣ The program is administered by the Clover Patch Camp director Dani-Leigh Ross.
- ♣ Camp is coordinated and facilitated by a licensed clinical social worker with over a decade of experience with the autism spectrum.
- ♣ Daily activities and curricula are led by special education teachers and senior camp counselors.

Is transportation provided?

- ♣ Transportation to and from camp is the responsibility of the camper

Frequently Asked Questions

Why should I send my child to Camp Spectacular?

- ♣ Camp fosters the development of social relationships with peers.
- ♣ Camp connects families and creates a social network beyond camp.
- ♣ Camp encourages teamwork and helps children to meet new people.
- ♣ Camp allows growth as individuals by exposure to new experiences.

What is the process for hiring camp staff? Will my child be safe?

- ♣ All potential camp employees complete a comprehensive application, including disclosure of criminal history and a complete background check (state and sexual offender databases).
- ♣ Each applicant completes a personal interview with camp administration. Three references are checked for every candidate.
- ♣ All employees are continually assessed during their employment at camp to ensure exemplary performance.

How do I apply?

- ♣ The application can be downloaded from the camp website or a hardcopy can be requested from the Camp office.
- ♣ There is no application deadline. We continue to accept applications until we are at full capacity.
- ♣ Applications are accepted on a first-come, first-served basis.
